

**Allowance Entitlements for the 2026/2027 Fiscal Year
(April 1, 2026 to March 31, 2027)**

ALLOWANCE	ENTITLEMENT
<p>Constituency Allowance</p> <p>Refer to Sections 4 to 7 and Sections 10 to 19 of the Members' Allowances Regulation</p>	<p>The entitlement for constituency expenses per region is <i>Winnipeg: \$78,394; Southern: \$72,692; and Northern: \$69,980</i>. This includes all expenses reimbursed for office space, office operation, representation, & staff salaries over the bi-weekly maximum.</p> <p>The annual maximum limit for representation expenses is \$11,759</p> <p>Capital equipment and furnishing items costing \$256 (including all applicable taxes) and over are property of the Legislative Assembly.</p> <p>New Members are entitled to an additional \$5,665 for capital expenses incurred for initial office set up.</p>
<p>Constituency Office Rent Allowance</p> <p>Refer to Sections 4(1) & (2) and Sections 16.4(1) & (2) of the Members' Allowances Regulation</p>	<p>The monthly maximum entitlement is \$2,853 for constituency office rent.</p> <p>Rent more than the monthly maximum is an expense to the Member's Constituency Allowance.</p>
<p>Constituency Assistants Allowance</p> <p>Refer to Section 2 of Members' Pay and Benefits Manual</p>	<p>The bi-weekly maximum entitlement is \$2,425 for Constituency Assistant's salary expenses.</p> <p>Salaries more than the bi-weekly maximum are an expense to the Member's Constituency Allowance.</p>
<p>Travel Allowance</p> <p>Refer to Sections 4 to 7 and Sections 20 to 21 of the Members' Allowances Regulation</p> <p>Kilometric Mileage Rate:</p> <p>Southern: 64.0¢/km Northern: 68.4¢/km</p>	<p>Winnipeg Members: Maximum entitlement is \$8,336.</p> <p>Southern Members: Maximum entitlement is the total of a Southern Member's individual base amount plus the calculation of 65 return trips by private vehicle at the kilometric mileage rate, between the Legislative Building and the Member's residence or place of nomination in the constituency.</p> <p>Northern Members: Maximum entitlement is the total of a base amount of \$19,901 plus the calculation of 52 round trips by air, based at the cost of airfare at April 1st, between the Winnipeg James Armstrong Richardson International Airport and the airstrip nearest the Member's residence or place of nomination in the constituency.</p> <p>Within a Member's maximum travel entitlement, up to \$4,857 is allowable for Out-of-Province travel expenses.</p> <p>Kilometres claimed over 25,000 will be reimbursed at an add'l 5¢/km</p>
<p>Commuter Allowance</p> <p>Refer to Sections 4 to 7 and Section 23 of the Members' Allowances Regulation</p>	<p>Eligible Members may claim the following:</p> <p>a) <u>Commuting Trips</u> – up to 6 round trips each sessional week, at the kilometric mileage rate, from the Member's residence in the Constituency to the City of Winnipeg limits, or up to 2 round trips each non-sessional week.</p> <p>b) <u>Contingency Stays</u> - up to 20 overnight stays in Winnipeg per sessional period, with a maximum of two meals per overnight stay at authorized meal rates.</p> <p>**Members claiming Commuter Allowance expenses are not eligible for the Living Allowance or the Alternate Living Allowance.</p>

ALLOWANCE	ENTITLEMENT
<p>Living Allowance</p> <p>Refer to Sections 4 to 7 and Sections 24 to 27 of the Members' Allowances Regulation regarding</p>	<p>Eligible Members may claim the following:</p> <p>a) <u>Temporary Residence Expenses</u> – up to a maximum of \$1,709 per month for costs related to rental accommodation or for costs related to a second-owned home.</p> <p>b) <u>Living Expenses</u> – for each month that the Legislative Assembly is in session, plus any month in which special or standing committees meet and for four additional months of the Member's choice: up to a maximum of \$1,096 per month for living expenses.</p> <p>For the remaining intersessional months in the fiscal year, a Member may claim up to a maximum of \$216 per month for living expenses.</p> <p><i>**Members claiming the Alternate Living Allowance or the Living Allowance are not eligible for the Commuter Allowance.</i></p>
<p>Moving Allowance (For eligible Members claiming the Living Allowance)</p> <p>Refer to Sections 4 to 7 and Section 27.1 of the Members' Allowances Regulation</p>	<p><u>Moving Allowance</u> - maximum per move is \$1,000 for authorized expenses for a move into or from the temporary/second owned residence.</p>
<p>Alternate Living Allowance</p> <p>Refer to Sections 4 to 7 and Section 28 of the Members' Allowances Regulation</p>	<p>Eligible Members may claim the following:</p> <p>For any month in which a Member is not claiming Living Allowance expenses, overnight stay expenses may be claimed consisting of:</p> <ul style="list-style-type: none"> - 8 overnight stays per month at a Winnipeg hotel/motel, - \$4.60 incidental expense for each overnight stay, and - meals at authorized meal rates <p><i>**Members claiming the Alternate Living Allowance or the Living Allowance are not eligible for the Commuter Allowance.</i></p>
<p>Intersessional Committee Allowance</p> <p>Refer to Sections 4 to 7 and Section 29 of the Members' Allowances Regulation</p>	<p>Members who are members of a Standing or Special Committee or the Legislative Assembly Management Commission, may claim for expenses related to attending the Committee meeting during an intersessional period.</p> <p>Committee expenses as approved by the Speaker.</p>
<p>Printing/Mailing to householders</p>	<p>All Members are entitled to 3 printings and 3 mailings to their constituents.</p>
